

Workflow





Member receives order from client. Member determines pricing.

2 Member enters Purchase Order into Ampersand System. Member sends PO to vendor electronically.

Ampersand receives invoice from Manufacturer and verifies accuracy on charges versus the Purchase Order.

Member is notified for approval resolution.

Ampersand pays Manufacturer and invoices Client in Member's Name per instructions in client maintenance/billing notes.



Payment from client is received and Ampersand pays funds to Member bi-monthly via direct deposit into your bank account.

Disbursements

- Disbursements are paid on the Gross Margin You are liable for all sales with a negative Gross Margin
- You will receive a detailed Disbursement Report itemizing each line item and its Gross Margin
- Funds are paid via direct deposit into your bank account



Collections

Made Easy



- Collections are your responsibility
- You are provided with A/R Aging weekly reports to keep your pulse on A/R
- Statements are sent to your customers on a monthly basis
- All A/R Aging over 60 days incur a 2% non-refundable penalty of the invoice amount
- All A/R Aging over 90 days incur a chargeback for the Cost of Goods

-To be reimbursed when A/R is paid, less a \$7.50 handling fee



Bad Debt

Insurance



- Protect your receivables against unforeseen circumstances and changes in the economy
- Sell to larger clients and take larger orders with financial security in mind
- Mandatory on all clients with a historical average A/R of > \$10,000
- Insurance expense is a cost, and shared jointly by The Ampersand Group and Member
- Claims are paid at 90% of Invoice total
- Never worry about bankruptcy, or bad debt again
